Account Monitoring. Client portfolios are monitored on an ongoing basis. The frequency of a portfolios rebalancing takes place when we at Pillar Wealth Management feel that there is an opportunity to sell into strength and buy into weakness.

Investment Authority. We manage investment accounts on a discretionary basis. Discretionary investment management means that the Advisor makes the ultimate decision to invest in a specific investment.

Investment Offerings. We provide advice on various types of investments. Our services are not limited to a specific type of investment and/or product.

Account Minimums and Other Requirements. In general, unless negotiated otherwise, we require a minimum household dollar amount of \$5,000,000.00 to open and maintain advisory accounts.

Item 3: Fees, Costs, Conflicts, and Standard of Conduct

At this time, Pillar Wealth Management has chosen to work with the following custodians: Charles Schwab and Fidelity. Pillar Wealth Management's advisory fees are separate from the fees charged by Charles Schwab and Fidelity. Pillar Wealth Management's annual advisory fee schedule(s) and details are as follows:

Pillar Wealth Management's advisory fees, are negotiated, and will not exceed 1.6% of Assets Under Management (AUM) and are based on complexity and guided by the total market value of the assets under advisory. Pillar Wealth Management does not charge additional fees over and above our agreed to advisory fee. Mutual funds and ETFs have internal fees and expenses, in which Pillar Wealth Management does not receive or share in these fees. Pillar Wealth Management, LLC clients may incur brokerage and other transaction costs by the custodian. Pillar Wealth Management does not receive these fees nor do we share in these fees; see ADV 2A Item 12 for additional information. Standard of Conduct:

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. An example of a conflict is Pillar Wealth Management receives additional compensation when a client adds money to increase the accounts value.

- **How might your conflicts of interests affect me, and how will you address them?**

How do your financial professionals make money?

Pillar Wealth Management, LLC investment advisory representatives are compensated based on the amount of client assets (i.e. Cash & Securities) under management in which they service.
